WHEREAS, the existing Tricycle Code of Iba, Zambales provides that tricycle franchise that expired for more than three (3) months is automatically cancelled and no longer valid for renewal;

WHEREAS, the COVID-19 pandemic that brought tremendous disruption to the normal lives of people around the world has crippled the transportation industry, including the tricycle sector;

WHEREAS, affected heavily in 2020, most of the tricycle operators in the Municipality of Iba fails to renew their franchise, much more resume normal tricycle operation;

WHEREAS, allowing them to renew their franchise that expire in 2019 is a great relief for them as they longer have to apply for a new franchise;

WHEREFORE, on motion of Kgd. Isagani Q. Yap, unanimously seconded, the Sangguniang Bayan in session assembled;


