CONSTRUCTION OF LINED CANAL ALONG WENCESLAO MORA ST. and D. CONSTRUCTION OF TRIPLE BARREL REINFORCE CONCRETE BOX CULVERT (RCBC) ALONG FLODELIZ ST. CROSSING BAYABA CREEK" to GMR CONSTRUCTION & SUPPLY";**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the projects "A. CONSTRUCTION OF LINED CANAL ALONG MOLAVE ST. ; B. CONSTRUCTION OF LINED CANAL ALONG WENCESLAO MORA ST.; C. CONSTRUCTION OF LINED CANAL ALONG BAÑO ST.; D. CONSTRUCTION OF TRIPLE BARREL REINFORCE CONCRETE BOX CULVERT (RCBC) ALONG FLODELIZ ST. CROSSING BAYABA CREEK" (INFRA 2022 – 03A-03B-03C-03D) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days;

WHEREAS, in response to the said advertisements, Two bid documents were submitted, first is from GMR CONSTRUCTION & SUPPLY and last is from KAE CONSTRUCTION SERVICES; two bidders paid the bid documents fee;

WHEREAS, the bid proposal of GMR CONSTRUCTION & SUPPLY and KAE CONSTRUCTION SERVICES met the requirements and criteria during bid opening dated February 8, 2022;

WHEREAS, upon recommendation of TWG, the bid proposal of KAE CONSTRUCTION SERVICES was declared Lowest Calculated Bid for the projects "A. CONSTRUCTION OF LINED CANAL ALONG MOLAVE ST., and C. CONSTRUCTION OF LINED CANAL ALONG BAÑO ST." and the bid proposal of GMR CONSTRUCTION & SUPPLY was declared Single calculated bid for the projects "B. CONSTRUCTION OF LINED CANAL ALONG WENCESLAO MORA ST. and D. CONSTRUCTION OF TRIPLE BARREL REINFORCE CONCRETE BOX CULVERT (RCBC) ALONG FLODELIZ ST. CROSSING BAYABA CREEK";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds KAE CONSTRUCTION SERVICES and GMR CONSTRUCTION & SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring KAE CONSTRUCTION SERVICES and GMR CONSTRUCTION & SUPPLY to pass the post qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project "A. CONSTRUCTION OF LINED CANAL ALONG MOLAVE ST., and C. CONSTRUCTION OF LINED CANAL ALONG BAÑO ST." to KAE CONSTRUCTION SERVICES and "B. CONSTRUCTION OF LINED CANAL ALONG WENCESLAO MORA ST. and D. CONSTRUCTION OF TRIPLE BARREL REINFORCE CONCRETE BOX CULVERT (RCBC) ALONG FLODELIZ ST. CROSSING BAYABA CREEK" to GMR CONSTRUCTION & SUPPLY.




