WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the projects A. CONCRETING OF INOCENCIA AGANA ST. AT BRGY. SAN AGUSTIN; B. CONCRETING OF PUROK 1 ROAD AT BRGY. DIRITA; C. CONCRETING OF PUROK 2 ROAD AT BRGY. DIRITA; D. CONSTRUCTION OF SLOPE PROTECTION / GROUTED RIPRAP AT TUGUE ROAD BRGY. ZONE 1; E. CONCRETING OF BENJAMINE FARIN SR. ST. PHASE II AT BRGY. ZONE 1 (INFRA 2022 – 04A-04B-04C-04D-04E) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for Twenty (20) days;

WHEREAS, in response to the said advertisements, two bid documents were submitted, first is from KAEE CONSTRUCTION SERVICES, and second is from GASAT BUILDERS AND SUPPLIES INC.; two bidders paid the bid documents fee;

WHEREAS, the bid proposal of KAEE CONSTRUCTION SERVICES and GASAT BUILDERS AND SUPPLIES INC. met the requirements and criteria during bid opening dated February 15, 2022;

WHEREAS, upon recommendation of TWG, the bid proposal of GASAT BUILDERS AND SUPPLIES INC. was declared Lowest calculated bid for the projects “A. CONCRETING OF INOCENCIA AGANA ST. AT BRGY. SAN AGUSTIN; B. CONCRETING OF PUROK 1 ROAD AT BRGY. DIRITA; C. CONCRETING OF PUROK 2 ROAD AT BRGY. DIRITA; D. CONSTRUCTION OF SLOPE PROTECTION / GROUTED RIPRAP AT TUGUE ROAD BRGY. ZONE 1; E. CONCRETING OF BENJAMINE FARIN SR. ST. PHASE II AT BRGY. ZONE 1”;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GASAT BUILDERS AND SUPPLIES INC. documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GASAT BUILDERS AND SUPPLIES INC. to pass the post qualification evaluation;




