BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF INSTRUCTIONAL AND JANITORIAL MATERIALS FOR ELEMENTARY AND SECONDARY SCHOOLS OF DEPED IBA DISTRICT" to I.L. FERNANDO GENERAL MERCHANDISE

RESOLUTION NO. GOODS G2022-21

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY AND DELIVERY OF INSTRUCTIONAL AND JANITORIAL MATERIALS FOR ELEMENTARY AND SECONDARY SCHOOLS OF DEPED IBA DISTRICT" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for eight (8) days dated December 19, 2022 to December 26, 2022;

WHEREAS, in response to the said advertisements, only one bid document was submitted from I.L. FERNANDO GENERAL MERCHANDISE from #62 Scout Madrinan St. South Triangle, Quezon City, this said bidder paid the bid documents fee and submitted her letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated October 24, 2022;

WHEREAS, upon recommendation of TWG, the bid proposal of I.L. FERNANDO GENERAL MERCHANDISE was declared Single Calculated Bid for the project "SUPPLY AND DELIVERY OF INSTRUCTIONAL AND JANITORIAL MATERIALS FOR ELEMENTARY AND SECONDARY SCHOOLS OF DEPED IBA DISTRICT";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds I.L. FERNANDO GENERAL MERCHANDISE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring I.L. FERNANDO GENERAL MERCHANDISE to pass the post-qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project "**SUPPLY AND DELIVERY OF INSTRUCTIONAL AND JANITORIAL MATERIALS FOR ELEMENTARY AND SECONDARY SCHOOLS OF DEPED IBA DISTRICT**" with project identification No. **GOODS 2022-21** to **I.L. FERNANDO GENERAL MERCHANDISE**;
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.




