BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF SERVICE VEHICLE (PICK UP) FOR THE TRANSPORT OF PERSONNEL, EQUIPMENT, SUPPLIES, PRODUCTS AND MATERIALS AND TO USE FOR INSPECTION AND SURVEY OF PROJECTS ESPECIALLY IN RURAL AND REMOTE AREAS" to BERZAN ENTERPRISE

RESOLUTION NO. GOODS G2022 - 20

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY AND DELIVERY OF SERVICE VEHICLE (PICK UP) FOR THE TRANSPORT OF PERSONNEL, EQUIPMENT, SUPPLIES, PRODUCTS AND MATERIALS AND TO USE FOR INSPECTION AND SURVEY OF PROJECTS ESPECIALLY IN RURAL AND REMOTE AREAS" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for twenty-one (21) days dated January 10, 2023 to January 30, 2023;

WHEREAS, in response to the said advertisements, only one bid document was submitted from BERZAN ENTERPRISE from #37 Capitol Drive, San Jose, Balanga City, Bataan, this said bidder paid the bid documents fee and submitted her letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated January 30, 2023;

WHEREAS, upon recommendation of TWG, the bid proposal of BERZAN ENTERPRISE was declared Single Calculated Bid for the project "SUPPLY AND DELIVERY OF SERVICE VEHICLE (PICK UP) FOR THE TRANSPORT OF PERSONNEL, EQUIPMENT, SUPPLIES, PRODUCTS AND MATERIALS AND TO USE FOR INSPECTION AND SURVEY OF PROJECTS ESPECIALLY IN RURAL AND REMOTE AREAS";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds BERZAN ENTERPRISE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring BERZAN ENTERPRISE to pass the post-qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."


NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.

RESOLVED at the Office of the Bids and Awards Committee this 6th day of February 2023.






