BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF DRUGS AND MEDICINES FOR USE IN HEALTH SERVICES UNIT OF LGU-IBA, ZAMBALES" to GCM PHARMACEUTICAL DEALER

RESOLUTION NO. GOODS G2023-09

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for " SUPPLY AND DELIVERY OF DRUGS AND MEDICINES FOR USE IN HEALTH SERVICES UNIT OF LGU-IBA, ZAMBALES" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEP's webpage continuously for twenty-four (24) days dated July 1, 2023 to July 24, 2023;

WHEREAS, in response to the said advertisements, only one bid document was submitted from GCM PHARMACEUTICAL DEALER located #109 4th St., Fortune 5 Village, Pasco de Blas, Valenzuela City. The bidder has fulfilled the necessary requirements by paying the bid documents fee and submitting her letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal submitted by GCM PHARMACEUTICAL DEALER met all the required criteria and requirements during the bid opening on July 24, 2023;

WHEREAS, upon recommendation of TWG, the bid proposal of GCM PHARMACEUTICAL DEALER was declared Single Calculated Bid for the project "SUPPLY AND DELIVERY OF DRUGS AND MEDICINES FOR USE IN HEALTH SERVICES UNIT OF LGU-IBA, ZAMBALES";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, the TWG has conducted post-qualification and evaluation of the bid proposal and found GCM PHARMACEUTICAL DEALER's bid documents to be substantially compliant with the requirements of the bidding process;

WHEREAS, the Bids and Awards Committee (BAC) has approved and adopted the TWG Post Qualification Report, declaring GCM PHARMACEUTICAL DEALER to have passed the post-qualification evaluation;


WHEREAS, Section 37.1.1 of the IRR states that "The BAC shall recommend to the Head of the Procuring Entity (HoPE) the award of the contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid, or Single Rated Responsive Bid after the post-qualification process has been completed"

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project "**SUPPLY AND DELIVERY OF DRUGS AND MEDICINES FOR USE IN HEALTH SERVICES UNIT OF LGU-IBA, ZAMBALES**" with project identification No. **GOODS 2023-09** to **GCM PHARMACEUTICAL DEALER**;
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


