BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF SCHOOL SUPPLIES FOR DAYCARE AND KINDER TO GRADE 10 STUDENTS OF DEPED IBA DISTRICT" to ANB ENTERPRISES

RESOLUTION NO. GOODS G2023-10

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for " SUPPLY AND DELIVERY OF SCHOOL SUPPLIES FOR DAYCARE AND KINDER TO GRADE 10 STUDENTS OF DEPED IBA DISTRICT" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for twenty (20) days dated July 25, 2023 to August 14, 2023;

WHEREAS, in response to the aforementioned advertisements, one bid document were submitted by ANB ENTERPRISES from Zone VI, Iba, Zambales. This bidder fulfilled the requirements by paying the bid document fee and submitting their respective letters of intent and applications for eligibility and bidding;

WHEREAS, during the bid opening on August 14, 2023, ANB ENTERPRISES' bid proposal were found to meet the necessary requirements and criteria;

WHEREAS, after careful evaluation and recommendation by the Technical Working Group (TWG), ANB ENTERPRISES was declared Single Calculated and Responsive Bid for the project "SUPPLY AND DELIVERY OF SCHOOL SUPPLIES FOR DAYCARE AND KINDER TO GRADE 10 STUDENTS OF DEPED IBA DISTRICT";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, subsequent to the post-qualification process and thorough evaluation of the bid proposal, the TWG determined that ANB ENTERPRISES' bid documents substantially complied with the requirements set forth in the bidding process;

WHEREAS, the Bids and Awards Committee (BAC) approved and adopted the TWG Post Qualification Report, affirming that ANB ENTERPRISES successfully passed the post-qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project "SUPPLY AND DELIVERY OF SCHOOL SUPPLIES FOR DAYCARE AND KINDER TO GRADE 10 STUDENTS OF DEPED IBA DISTRICT" with project identification No. **GOODS 2023-10** to ANB ENTERPRISES;
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


