BAC Resolution Recommending the Award of The Project
“CONSTRUCTION OF LINED CANAL IN PULTAMAYOR ST., BRGY. ZONE V, IBA,
ZAMBALES”
to GMR CONSTRUCTION AND SUPPLY

RESOLUTION NO. INFRA I2023-07

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the projects CONSTRUCTION OF LINED CANAL IN PULTAMAYOR ST., BRGY. ZONE V, IBA, ZAMBALES (INFRA 2023-07) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for Twenty – three (23) days;

WHEREAS, in response to the said advertisements, two bid documents were received from KAEE CONSTRUCTION SERVICES, and from GMR CONSTRUCTION & SUPPLY. Two bidders paid the bid documents fee;

WHEREAS, the bid proposal of KAEE CONSTRUCTION SERVICES and GMR CONSTRUCTION & SUPPLY met the requirements and criteria during bid opening dated September 6, 2023;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION AND SUPPLY was declared Lowest Calculated Bid for the project “CONSTRUCTION OF LINED CANAL IN PULTAMAYOR ST., BRGY. ZONE V, IBA, ZAMBALES (INFRA 2023-07)”

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION AND SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR CONSTRUCTION AND SUPPLY to pass the post qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


